OHSLA Representative to the Midwest Chapter Submitted by Ximena Chrisagis

Midwest Chapter/MLA State Liaisons Committee

Did you know that OHSLA has its own representative to the Midwest Chapter/MLA and that representative serves on the Midwest Chapter/MLA's State Liaisons Committee? I am currently serving as OHSLA's representative/liaison.

How is the liaison selected?

OHSLA's liaison is appointed by the OHSLA President. The liaison must be an active member of both the Midwest Chapter/MLA and OHSLA. The OHSLA liaison is usually appointed for a minimum of two years but may serve longer at the discretion of the OHSLA President.

What do I do as the OHSLA Representative?

- I serve as conduit for communication between the Midwest Chapter/MLA and OHSLA, local library groups, and library science education programs.
- I promote chapter activities and membership.
- I participate in recommendations to the Midwest Chapter/MLA Executive Board on all policies relating to relations with state health sciences library associations.
- I document state liaison policies and procedures on the chapter website and other relevant publications.

How do I fulfill this charge?

- I attend both OHSLA and Midwest Chapter/MLA business meetings regularly.
- I attend OHSLA Board meetings as a non-voting member.
- I either attend or seek a volunteer to serve as my proxy to ensure that OHSLA and the Midwest Chapter/MLA have an active member to promote both organizations at relevant professional or library school events such as the KSU Career Fairs in Kent and in Columbus. (Clare Leibfarth and Mike McGraw are representing the Midwest Chapter/MLA at Kent's fair this year, and Stephanie Schulte is the representative at the Columbus location).
- I gather news about OHSLA and its members for inclusion in *MIDLINE*, the Midwest Chapter/MLA newsletter.
- I communicate with the OHSLA membership about relevant developments at the Midwest Chapter/MLA level.

What can you do to help me be more effective in my role as liaison?

- Send me (ximena.chrisagis@wright.edu) news about new staff, new services and programs, etc. at your libraries. Remember that programs and services you implement in your library could well be of interest to Ohio Midwest Chapter/MLA members who may not be members of OHSLA—as well as to Midwest Chapter/MLA members outside of Ohio. I need your help to keep up with relevant developments in Ohio health sciences libraries.
- Let me know if you have suggestions about how I can serve you better.

End-of-Life Library in Cleveland

The Hospice Institute of Hospice of the Western Reserve in Cleveland, Ohio has recognized the need for access to quality educational resources related to end-of-life care and has created a specialized library to meet those needs. Its mission is to provide healthcare professionals both within and outside of our organization with the tools necessary to give quality palliative and end-of-life care and to support ongoing research into related topics. Personalized library services are free of charge to members of both the healthcare community and the public. These library materials help increase understanding, awareness and acceptance of the physical, emotional, psychological and spiritual transitions that occur at the end of life.

The library houses over 1100 titles related to hospice and palliative care, death, dying and bereavement, as well as specialized journals and archival material from the early days of the hospice movement. The children's collection supports our Pediatric Care Program and offers assistance to providers who may have few pediatric resources. Literature searches provide information to help navigate the complex end-of-life needs of an increasingly diverse society.

The materials supplied by the library support the continuing education and research needs of physicians, nurses, social workers and other healthcare providers all over the United States, including many underserved areas. Research articles supplied by the library have been used to increase the application of evidence based practice in hospice and palliative care settings and to create institutional policies and procedures to improve the quality of care provided at the end of life.

In addition to standard library services, the library website contains links to several databases which assist researchers to identify appropriate measurement instruments for use in their studies. Behavioral Measures Core, developed at the Case Comprehensive Center of Case Western Reserve University, and Primary Care Core, funded by a Title VII grant from the Health Resources Administration are two databases containing behavioral measurement tools useful for hospice and palliative care researchers' projects. The database provides information about the measure, key references and copies of the measure when available. The library website also has links to pain and palliative care measurement tools and a Bioethics link.

The Hospice of the Western Reserve End-of-Life Library may be accessed in several ways. The library website is http://www.hospicewr.org/Library_Search.asp. March 1, 2010, Cincinnati, Ohio: It is official. After months of planning and preparation, The Jewish Hospital is now a member of Mercy Health Partners (MHP). The Jewish Hospital joins with the Mercy hospitals in Anderson Township, Batavia, Fairfield, Mt. Airy and Western Hills, as well as medical centers in Harrison and Mt. Orab. The Jewish Foundation, which owned Jewish Hospital, announced in July 2009 that they would enter into exclusive negotiations with MHP for the sale of Jewish Hospital. The Health Sciences Library continues as the library for Jewish Hospital - its residencies, medical staff, nurses, allied health staff, and management - will be served by existing staff. Like Mercy Health Partners, The Jewish Hospital has a history of serving Greater Cincinnati that spans more than 150 years. It was the first Jewish Hospital to open in the United States when it was founded in 1850 to treat Jewish immigrants in Cincinnati. Our mission statement: "The Jewish Hospital is a community hospital faithful to its Jewish Heritage and grounded in the Jewish and Catholic traditions of service to the community. Our purpose is to reveal God's love for all, especially the poor and vulnerable, through the delivery of compassionate health care services and education of health care professionals."
